# Chris Packham's legal challenge appeal

Naturalist and campaigner Chris Packham launched a case to review the government's decision over HS2. This was dismissed by the High Court, however the Court of Appeal decided to hear the case on 8 July 2020. One of the key reasons Lord Justice Lewison gave for approving the hearing was the 'considerable public interest' that has been shown.

The judges reserved their ruling.

## Iron Age skeleton discovered in Wendover

An Iron Age skeleton with his hands bound has been discovered by HS2 project archaeologists, who believe he may be a murder victim. ## **Infrastructure and Projects Authority Annual Report**

The Infrastructure and Projects Authority has just released their annual report. HS2 has fallen from a classification of Amber/Red which it has held for 7 years to Red in the latest report. A red classification means "successful delivery appears to be unachievable, and the project may need to be re-scoped or have its overall viability reconsidered".
